## 1 Introduction

This document is not a full course in Quantum Computing. My goal in producing it was to create a collection of qubit circuit identities that are used in Quantum Computing. Mathematicians and Physicists may consider it as being analogous to a Table of Integrals or a Mathematical Handbook such as Gradshteyn \& Ryzhik or Abramowitz \& Stegun. Computer Programmers may think of it as a scrapbook of code snippets that are elegant, instructive, well documented, and useful. Electronics experts may view it as a compendium of circuits for performing a large assortment of tasks.

The vast majority of the circuit identities collected in this work were not discovered for the first time by me, and I take no credit for discovering them. In producing this document, I am acting as a collector, not as a discoverer.

I plan to continue adding qubit circuit identities to this collection, and to release future versions of this document containing the new specimens. For example, there are some nice identities involving quantum error correction and quantum compiling that I have not included yet, but which I plan to include in future versions. Suggestions and comments are welcomed and appreciated.

This document benefitted greatly from the wonderful LaTeX macros: QCircuit (by B. Eastin, S. T. Flammia) and XYPic (by K.H. Rose and R.R. Moore), on which QCircuit is based.

## 2 Notation

Let Bool $=\{0,1\}$. For integers $a$ and $b$ such that $a \leq b$, let $Z_{a, b}=\{a, a+1, a+2, \ldots b\}$. $\delta(x, y)$ and $\delta_{y}^{x}$ will both denote the Kronecker delta function. It equals one when $x=y$ and zero otherwise.

For any statement $\mathcal{S}$, we define the truth function $\theta(\mathcal{S})$ to equal 1 if $\mathcal{S}$ is true and 0 if $\mathcal{S}$ is false. For example, $\theta(x>0)$ represents the unit step function and $\delta(x, y)=\theta(x=y)$ the Kronecker delta function.
$\oplus$ will denote addition mod 2. Hence, for any $a, b \in B o o l, a \oplus b=a+b-2 a b$ and $(-1)^{a \oplus b}=(-1)^{a+b}$. When speaking of bits with states 0 and 1 , we will often use an overline to represent the opposite state: $\overline{0}=1, \overline{1}=0$. Note that if $x, k \in$ Bool, then $\sum_{k}(-1)^{k x}=1+(-1)^{x}=2 \delta(x, 0)$. For $x \in \operatorname{Bool}, \delta(x, 1)=x$.

We will often use $N_{S}=2^{N_{B}}$, where $N_{B}$ stands for number of bits and $N_{S}$ for number of states. We will use lower case Latin letters $a, b, c \ldots \in$ Bool to represent bit values and lower case Greek letters $\alpha, \beta, \gamma, \ldots \in Z_{0, N_{B}-1}$ to represent bit positions.

Given a binary vector $\vec{x} \in$ Bool $^{N_{B}}$, if its components are labelled as follows: $\vec{x}=\left(x_{N_{B}-1}, x_{N_{B}-2}, \ldots, x_{1}, x_{0}\right)$, then we will say that the components of $\vec{x}$ are labelled naturally. For some applications, it is very convenient to use natural labelling. For other applications, it doesn't much matter whether we use natural labelling or not. In cases where it doesn't matter, we may use other common labellings such as $\vec{x}=$ $\left(x_{1}, x_{2}, \ldots, x_{N_{B}}\right)$.

Let $\vec{\nu}=\left(N_{B}-1, N_{B}-2, \ldots, 1,0\right)$, and $2^{\vec{\nu}}=\left(2^{N_{B}-1}, 2^{N_{B}-2}, \ldots, 2^{1}, 2^{0}\right)$.
Given any $x \in Z_{0, N_{S}-1}$, we can write $x=\sum_{i=0}^{N_{B}-1} 2^{i} x_{i}$. If we define the naturally labelled binary vector $\vec{x}=\left(x_{N_{B}-1}, \ldots, x_{1}, x_{0}\right)$, then $x=2^{\vec{\nu}} \cdot \vec{x}$. We call $\vec{x}=\left(x_{N_{B}-1}, \ldots, x_{1}, x_{0}\right)$ the binary representation of $x$ and denote it by $\operatorname{bin}(x)$.

Given any naturally labelled binary vector $\vec{x}=\left(x_{N_{B}-1}, \ldots, x_{1}, x_{0}\right)$, we can write $x=2^{\vec{\nu}} \cdot \vec{x}$. We call $x \in Z_{0, N_{S}-1}$ the decimal representation of $\vec{x}$ and denote it by $\operatorname{dec}(\vec{x})$.

If $\vec{x}, \vec{y} \in$ Bool $^{N_{B}}$, we will use $\vec{x} \cdot \vec{y}=\sum_{i=0}^{N_{B}-1} x_{i} y_{i}$, where the addition is normal, not $\bmod 2$.

We define the single-qubit states $|0\rangle$ and $|1\rangle$ by

$$
|0\rangle=\left[\begin{array}{l}
1  \tag{1}\\
0
\end{array}\right], \quad|1\rangle=\left[\begin{array}{l}
0 \\
1
\end{array}\right]
$$

Given any $\vec{x}=\left(x_{1}, x_{2}, \ldots, x_{N_{B}}\right) \in$ Bool $^{N_{B}}$, and given a vector of distinct qubit labels $\vec{\beta}=\left(\beta_{1}, \beta_{2}, \ldots, \beta_{N_{B}}\right)$, we define the $N_{B}$-qubit state $|\vec{x}\rangle$ as the following tensor product

$$
\begin{equation*}
|\vec{x}\rangle=|\vec{x}\rangle_{\vec{\beta}}=\left|x_{1}\right\rangle_{\beta_{1}}\left|x_{2}\right\rangle_{\beta_{2}} \ldots\left|x_{N_{B}}\right\rangle_{\beta_{N_{B}}}=\left|x_{1}\right\rangle \otimes\left|x_{2}\right\rangle \ldots \otimes\left|x_{N_{B}}\right\rangle . \tag{2}
\end{equation*}
$$

For example,

$$
|01\rangle=\left[\begin{array}{l}
1  \tag{3}\\
0
\end{array}\right] \otimes\left[\begin{array}{l}
0 \\
1
\end{array}\right]=\left[\begin{array}{l}
0 \\
1 \\
0 \\
0
\end{array}\right]
$$

With natural labelling, we would use $\vec{x}=\left(x_{N_{B}-1}, \ldots, x_{1}, x_{0}\right), \vec{\beta}=\vec{\nu}$ and $x=$ $\sum_{i=0}^{N_{B}-1} 2^{i} x_{i}$. Instead of Eq. (2), we would have

$$
\begin{equation*}
|x\rangle=|\vec{x}\rangle=|\vec{x}\rangle_{\vec{\nu}}=\left|x_{N_{B}-1}\right\rangle_{N_{B}-1} \ldots\left|x_{1}\right\rangle_{1}\left|x_{0}\right\rangle_{0}=\left|x_{N_{B}-1}\right\rangle \otimes \ldots \otimes\left|x_{1}\right\rangle \otimes\left|x_{0}\right\rangle \tag{4}
\end{equation*}
$$

Of course, any $N_{B}$ qubit state can be obtained as a linear combination of the states $|\vec{x}\rangle$ for all $\vec{x} \in$ Bool $^{N_{B}}$.
$I_{r}$ will represent the $r$ dimensional unit matrix, for any integer $r \geq 1$.
Suppose $\vec{\beta}=\left(\beta_{1}, \beta_{2}, \ldots, \beta_{N_{B}}\right)$ is a vector of bit labels, $\left(M_{1}, M_{2}, \ldots, M_{N_{B}}\right)$ is a vector of $2 \times 2$ complex matrices, and $\left(\phi_{1}, \phi_{2}, \ldots, \phi_{N_{B}}\right)$ is a vector of 2-dimensional complex column vectors. For $i \in Z_{1, N_{B}}$, we define $M_{i}\left(\beta_{i}\right)$ by

$$
\begin{equation*}
M_{i}\left(\beta_{i}\right)=I_{2} \otimes \cdots \otimes I_{2} \otimes M_{i} \otimes I_{2} \otimes \cdots \otimes I_{2} \tag{5}
\end{equation*}
$$

where the matrix $M_{i}$ on the right hand side is located at bit position $i$ (counting from left to right, starting at 1) in the tensor product of $N_{B} 2 \times 2$ matrices. We often define a product operator $M(\vec{\beta})$ by

$$
\begin{equation*}
M(\vec{\beta})=\prod_{i=1}^{N_{B}} M_{i}\left(\beta_{i}\right)=M_{1}\left(\beta_{1}\right) \otimes M_{2}\left(\beta_{2}\right) \otimes \ldots M_{N_{B}}\left(\beta_{N_{B}}\right), \tag{6}
\end{equation*}
$$

and a product state $|\phi\rangle_{\vec{\beta}}$

$$
\begin{equation*}
|\phi\rangle_{\vec{\beta}}=\prod_{i=1}^{N_{B}}\left|\phi_{i}\right\rangle_{\beta_{i}}=\left|\phi_{1}\right\rangle \otimes\left|\phi_{2}\right\rangle \otimes \ldots\left|\phi_{N_{B}}\right\rangle . \tag{7}
\end{equation*}
$$

For example, we might find it useful to define an operator $M(\vec{\beta})$ and a state $|\phi\rangle_{\vec{\beta}}$ by

$$
\begin{gather*}
M(\vec{\beta})=\prod_{i=1}^{N_{B}} \sigma_{X}\left(\beta_{i}\right)=\sigma_{X} \otimes \sigma_{X} \otimes \ldots \otimes \sigma_{X}  \tag{8}\\
|\phi\rangle_{\vec{\beta}}=|0\rangle_{\vec{\beta}}=\prod_{i=1}^{N_{B}}|0\rangle_{\beta_{i}}=\binom{1}{0} \otimes\binom{1}{0} \otimes \cdots \otimes\binom{1}{0}=[1,0,0, \ldots, 0]^{T} . \tag{9}
\end{gather*}
$$

With natural labelling, we use $\vec{\beta}=\vec{\nu}$. Let $\left(M_{N_{B}-1}, \ldots, M_{1}, M_{0}\right)$ be a vector of $2 \times 2$ complex matrices, and let $\left(\phi_{N_{B}-1}, \ldots, \phi_{1}, \phi_{0}\right)$ be a vector of 2 -dimensional complex column vectors. With natural labelling, for $i \in Z_{0, N_{B}-1}$, we define $M_{i}(i)$ by

\begin{equation*}
M_{i}(i)=I_{2} \otimes \cdots \otimes I_{2} \otimes M_{i} \otimes I_{2} \otimes \cdots \otimes I_{2} \tag{10}
\end{equation*}
$$

where the matrix $M_{i}$ on the right hand side is located at bit position $i$ (counting from right to left, starting at 0 ) in the tensor product of $N_{B} 2 \times 2$ matrices. We often define a product operator $M(\vec{\nu})$ by

$$
\begin{equation*}
M(\vec{\nu})=\prod_{i=0}^{N_{B}-1} M_{i}(i)=M_{N_{B}-1}\left(N_{B}-1\right) \otimes \ldots \otimes M_{1}(1) \otimes M_{0}(0) \tag{11}
\end{equation*}
$$

and a product state $|\phi\rangle_{\vec{\nu}}$

$$
\begin{equation*}
|\phi\rangle_{\vec{\nu}}=\prod_{i=0}^{N_{B}-1}\left|\phi_{i}\right\rangle_{i}=\left|\phi_{N_{B}-1}\right\rangle \otimes \ldots \otimes\left|\phi_{1}\right\rangle \otimes\left|\phi_{0}\right\rangle . \tag{12}
\end{equation*}
$$

Next we explain our circuit diagram notation. In our qubit circuit diagrams, each horizontal wire represents a single qubit (except when stated explicitly that the wire represents several qubits). Different wires represent different qubits. We label single qubit wires by Greek letters or by integers as follows:

$$
\begin{array}{cc}
-\alpha & -0  \tag{13}\\
\text { - } \beta & \text { - } 1 \\
-\gamma & \text { - } 2 \\
-\delta & -3 \\
\vdots & \vdots
\end{array} .
$$

Thus, the first (topmost) wire is labelled either $\alpha$ or 0 , the second wire is labelled either $\beta$ or 1 , and so forth. For some special applications, we label qubits differently from Eq.(13). For example, we might label the first two wires $\alpha_{1}, \alpha_{2}$, and the next two wires $\beta_{1}, \beta_{2}$, or we might want to label the first wire ( $\alpha_{1}, \alpha_{2}$ ), and make it represent
two qubits. In cases where bit labelling is different from Eq.(13), this will be stated explicitly. Bras are represented by

$$
\begin{equation*}
\left|\psi_{1}\right\rangle_{\alpha}\left|\psi_{2}\right\rangle_{\beta}=-\frac{-\left|\psi_{1}\right\rangle}{-\left|\psi_{2}\right\rangle},|\psi\rangle_{\alpha \beta}=-|\psi\rangle \tag{14}
\end{equation*}
$$

and kets by

$$
\begin{equation*}
\left\langle\chi _ { 1 } | _ { \alpha } \left\langle\left.\chi_{2}\right|_{\beta}=\frac{\left\langle\chi_{1}\right|}{\left\langle\chi_{2}\right|},\left\langle\left.\chi\right|_{\alpha \beta}=\quad\langle\chi|\right.\right.\right. \tag{15}
\end{equation*}
$$

Operators are represented by

$$
T_{1}(\alpha) T_{2}(\beta)=\begin{array}{|}
\sqrt{T_{1}}  \tag{16}\\
\sqrt{T_{2}}
\end{array}, T(\alpha, \beta)=\sqrt{T} .
$$

Matrix elements are represented by combining the above rules for bras, kets, and operators. For example,

$$
\begin{equation*}
\left\langle\left.\chi\right|_{\alpha \beta} T(\alpha, \beta) \mid \psi\right\rangle_{\alpha \beta}=\langle\chi|-T-|\psi\rangle . \tag{17}
\end{equation*}
$$

Note that in our circuit diagrams, time flows from the right to the left of the diagram. Careful: Many workers in Quantum Computing draw their diagrams so that time flows from left to right. We eschew their convention because it forces one to reverse the order of the operators every time one wishes to convert between a circuit diagram and its algebraic equivalent in Dirac Notation.

Next, we will introduce a slight enhancement to the standard Dirac Notation. Given a ket $|\psi\rangle$, if we can find an operator $\Omega$ such that $|\psi\rangle$ is a unique (up to a scalar factor) eigenvector of $\Omega$ with eigenvalue $\lambda$, then we will sometimes denote $|\psi\rangle$ by $|\Omega=\lambda\rangle$. Sometimes, in order to specify $|\psi\rangle$ uniquely, one needs to find a complete set of commuting operators $\left\{\Omega_{i}: i \in Z_{1, N}\right\}$ such that $\Omega_{i}|\psi\rangle=\lambda_{i}|\psi\rangle$ for all $i$, and then we can denote $|\psi\rangle$ by $|\vec{\Omega}=\vec{\lambda}\rangle$. Note that if $U$ is a unitary operator that acts on the same Hilbert space as an operator $\Omega$, then $\left|U \Omega U^{\dagger}=\lambda\right\rangle=U|\Omega=\lambda\rangle$. If operator $\Omega$ has an eigenspace with eigenvalue $\lambda$, then we denote the projector onto that eigenspace by $\pi(\Omega=\lambda)$. If the eigenspace is one dimensional, then $\pi(\Omega=$ $\lambda)=|\Omega=\lambda\rangle\langle\Omega=\lambda|$. If the eigenspace has dimension greater than one, then we can always find an orthonormal basis $\left\{\left|\psi_{\lambda}^{i}\right\rangle: i \in S\right\}$ for the eigenspace, and then $\pi(\Omega=\lambda)=\sum_{i \in S}\left|\psi_{\lambda}^{i}\right\rangle\left\langle\psi_{\lambda}^{i}\right|$. Note that if $U$ is a unitary operator that acts on the same Hilbert space as operator $\Omega$, then $U \pi(\Omega=\lambda) U^{\dagger}=\pi\left(U \Omega U^{\dagger}=\lambda\right)$.

The Pauli matrices are defined by:

$$
\sigma_{X}=\left(\begin{array}{ll}
0 & 1  \tag{18}\\
1 & 0
\end{array}\right), \quad \sigma_{Y}=\left(\begin{array}{cc}
0 & -i \\
i & 0
\end{array}\right), \quad \sigma_{Z}=\left(\begin{array}{cc}
1 & 0 \\
0 & -1
\end{array}\right)
$$

More information about the Pauli matrices may be found in the section entitled Pauli Matrices.

We will often abbreviate $n$-fold tensor products of Pauli matrices as follows. If $w_{1}, w_{2}, \ldots, w_{n} \in\{X, Y, Z\}$, and $b_{1}, b_{2}, \ldots, b_{n} \in$ Bool, then let

$$
\begin{equation*}
\sigma_{w_{1}, w_{2}, \ldots, w_{n}}^{b_{1}, b_{2}, \ldots, b_{n}}=\sigma_{w_{1}}^{b_{1}} \otimes \sigma_{w_{2}}^{b_{2}} \otimes \ldots \otimes \sigma_{w_{n}}^{b_{n}} \tag{19}
\end{equation*}
$$

For example, $\sigma_{X Y Y}^{1,0,1}=\sigma_{X}{ }^{1} \otimes \sigma_{Y}{ }^{0} \otimes \sigma_{Y}{ }^{1}$. Equivalently, for $n$ bits $\vec{\alpha}=\left(\alpha_{1}, \alpha_{2}, \ldots \alpha_{n}\right)$,

$$
\begin{equation*}
\sigma_{w_{1}, w_{2}, \ldots, w_{n}}^{b_{1}, b_{2}, \ldots, b_{n}}(\vec{\alpha})=\prod_{i=1}^{n} \sigma_{w_{i}}^{b_{i}}\left(\alpha_{i}\right) \tag{20}
\end{equation*}
$$

Also let

$$
\begin{equation*}
\sigma_{w_{1}, w_{2}, \ldots, w_{n}}=\sigma_{w_{1}, w_{2}, \ldots, w_{n}}^{1,1, \ldots, 1}=\sigma_{w_{1}} \otimes \sigma_{w_{2}} \otimes \ldots \otimes \sigma_{w_{n}} \tag{21}
\end{equation*}
$$

For example, $\sigma_{X Y Y}=\sigma_{X Y Y}^{1,1,1}=\sigma_{X} \otimes \sigma_{Y} \otimes \sigma_{Y}$.
It is sometimes convenient to define the following operator for any $x, z \in$ Bool and any qubit $\alpha$ :

$$
\begin{equation*}
\Lambda^{x, z}(\alpha)=\sigma_{X}^{x}(\alpha) \sigma_{Z}^{z}(\alpha) \tag{22}
\end{equation*}
$$

Note that $\Lambda^{x, z \dagger}=(-1)^{x z} \Lambda^{x, z}$, and $\Lambda^{00}=1, \Lambda^{10}=\sigma_{X}, \Lambda^{11}=(-i) \sigma_{Y}, \Lambda^{00}=\sigma_{Z} . \Lambda^{x, z}$ arises, for example, when dealing with Bell states.

For any $j \in$ Bool and $w_{1}, w_{2} \in\{X, Y, Z\}$, let $\Pi_{w_{1}, w_{2}}^{j}$ be the projection operator that projects the 2 qubit Hilbert space onto the eigenspace of $\sigma_{w_{1}, w_{2}}$ with eigenvalue $(-1)^{j}$. Thus,

$$
\begin{equation*}
\Pi_{w_{1}, w_{2}}^{j}=\pi\left[\sigma_{w_{1}, w_{2}}=(-1)^{j}\right] . \tag{23}
\end{equation*}
$$

Note that

$$
\sigma_{Z Z}=\sigma_{Z} \otimes \sigma_{Z}=\left(\begin{array}{cc}
1 & 0  \tag{24}\\
0 & -1
\end{array}\right) \otimes\left(\begin{array}{cc}
1 & 0 \\
0 & -1
\end{array}\right)=\operatorname{diag}(1,-1,-1,1)
$$

From Eq.(24), it is clear that for any $j, a, b \in$ Bool,

$$
\begin{equation*}
\Pi_{Z Z}^{j}|a, b\rangle=\delta_{a \oplus b}^{j}|a, b\rangle \tag{25}
\end{equation*}
$$

## 3 Pauli Matrices

The Pauli matrices are defined by:

$$
\sigma_{X}=\left(\begin{array}{ll}
0 & 1  \tag{26}\\
1 & 0
\end{array}\right), \quad \sigma_{Y}=\left(\begin{array}{cc}
0 & -i \\
i & 0
\end{array}\right), \quad \sigma_{Z}=\left(\begin{array}{cc}
1 & 0 \\
0 & -1
\end{array}\right)
$$

Sometimes one refers to $\sigma_{X}, \sigma_{Y}, \sigma_{Z}$ as $\sigma_{1}, \sigma_{2}, \sigma_{3}$, respectively. One can then use $\sigma_{0}$ to denote the $2 \times 2$ identity matrix. It is often convenient to use the vector of Pauli matrices $\vec{\sigma}=\left(\sigma_{X}, \sigma_{Y}, \sigma_{Z}\right)$.

All 3 Pauli matrices are their own inverses:

$$
\begin{equation*}
\sigma_{X}^{2}=\sigma_{Y}^{2}=\sigma_{Z}^{2}=1 \tag{27}
\end{equation*}
$$

Distinct Pauli matrices anticommute. For example,

$$
\begin{equation*}
\sigma_{X} \sigma_{X}=-\sigma_{Y} \sigma_{X} \tag{28}
\end{equation*}
$$

It is easy to check that

$$
\begin{equation*}
\sigma_{X} \sigma_{Y}=i \sigma_{Z}, \quad \sigma_{Y} \sigma_{Z}=i \sigma_{X}, \quad \sigma_{Z} \sigma_{X}=i \sigma_{Y} \tag{29}
\end{equation*}
$$

Note that Eqs.(27), (28) and (29) specify a $3 \times 3$ multiplication table for the 3 Pauli matrices with each other.

For $w \in\{X, Y, Z\}$, if $\left|+_{w}\right\rangle$ and $\left|-{ }_{w}\right\rangle$ represent the eigenvectors of $\sigma_{w}$ with eigenvalues +1 and -1 , respectively, then

$$
\begin{gather*}
\left|+_{X}\right\rangle=\frac{1}{\sqrt{2}}\binom{1}{1}, \quad\left|-{ }_{X}\right\rangle=\frac{1}{\sqrt{2}}\binom{1}{-1},  \tag{30}\\
\left|+_{Y}\right\rangle=\frac{1}{\sqrt{2}}\binom{1}{i},\left|-_{Y}\right\rangle=\frac{1}{\sqrt{2}}\binom{1}{-i},  \tag{31}\\
\left|+{ }_{Z}\right\rangle=\binom{1}{0},\left|-_{Z}\right\rangle=\binom{0}{1} . \tag{32}
\end{gather*}
$$

We define

$$
\begin{equation*}
|0\rangle=|+z\rangle \tag{33}
\end{equation*}
$$

and

$$
\begin{equation*}
|1\rangle=|-z\rangle . \tag{34}
\end{equation*}
$$

We will use $n$ to denote the "number operator". Thus,

$$
n=\left(\begin{array}{ll}
0 & 0  \tag{35}\\
0 & 1
\end{array}\right)=\left|-{ }_{Z}\right\rangle\left\langle-{ }_{Z}\right|=\frac{1-\sigma_{Z}}{2}
$$

and

$$
\bar{n}=1-n=\left(\begin{array}{ll}
1 & 0  \tag{36}\\
0 & 0
\end{array}\right)=\left|+{ }_{Z}\right\rangle\left\langle+_{Z}\right|=\frac{1+\sigma_{Z}}{2} .
$$

Since $n$ and $\sigma_{Z}$ are diagonal, it is easy to see that

$$
\begin{equation*}
\sigma_{Z}=(-1)^{n}=1-2 n . \tag{37}
\end{equation*}
$$

Most of the definitions and results stated so far for $\sigma_{Z}$ have counterparts for $\sigma_{Z}$ and $\sigma_{Y}$. The counterpart results can be easily proven by applying a rotation that interchanges the coordinate axes. Let $w \in\{X, Y, Z\}$. If $\left|+{ }_{w}\right\rangle$ and $\left|-{ }_{w}\right\rangle$ represent the eigenvectors of $\sigma_{w}$ with eigenvalues +1 and -1 , respectively, then we define

$$
\begin{equation*}
\left|0_{w}\right\rangle=\left|+_{w}\right\rangle \tag{38}
\end{equation*}
$$

and

$$
\begin{equation*}
\left|1_{w}\right\rangle=\left|-{ }_{w}\right\rangle . \tag{39}
\end{equation*}
$$

Let

$$
\begin{gather*}
n_{w}=\left|-{ }_{w}\right\rangle\left\langle-{ }_{w}\right|=\frac{1-\sigma_{w}}{2},  \tag{40}\\
\bar{n}_{w}=1-n_{w}=\left|+{ }_{w}\right\rangle\left\langle+_{w}\right|=\frac{1+\sigma_{w}}{2} . \tag{41}
\end{gather*}
$$

As when $w=Z$, one has

$$
\begin{equation*}
\sigma_{w}=(-1)^{n_{w}}=1-2 n_{w} . \tag{42}
\end{equation*}
$$

Note that whenever we use $|0\rangle,|1\rangle$ or $n$, without an $X, Y$ or $Z$ subscript, the subscript $Z$ should be inferred.

The one bit Hadamard matrix is defined by:

H=\frac{1}{\sqrt{2}}\left(\begin{array}{cc}
1 & 1  \tag{43}\\
1 & -1
\end{array}\right)=\frac{1}{\sqrt{2}}\left(\sigma_{X}+\sigma_{Z}\right)
$$

It is easy to check that

\begin{gather*}
H^{2}=1  \tag{44}\\
H \sigma_{X} H=\sigma_{Z}, H \sigma_{Z} H=\sigma_{X}  \tag{45}\\
\left|0_{X}\right\rangle=\frac{|0\rangle+|1\rangle}{\sqrt{2}}=H|0\rangle  \tag{46}\\
\left|1_{X}\right\rangle=\frac{|0\rangle-|1\rangle}{\sqrt{2}}=H|1\rangle \tag{47}
\end{gather*}
$$

The matrix $i^{n}$ is defined by

$$
i^{n}=\left(\begin{array}{ll}
1 & 0  \tag{48}\\
0 & i
\end{array}\right)
$$

It is easy to check that

$$
\begin{gather*}
\left(i^{n}\right)^{2}=\sigma_{Z},  \tag{49}\\
i^{n} \sigma_{X} i^{-n}=\sigma_{Y}, i^{-n} \sigma_{X} i^{n}=-\sigma_{Y} . \tag{50}
\end{gather*}
$$

Note that for $a, b \in$ Bool,

$$
\begin{gather*}
\sigma_{X}{ }^{b}|a\rangle=|a \oplus b\rangle  \tag{51}\\
\sigma_{Z}^{b}|a\rangle=(-1)^{a b}|a\rangle  \tag{52}\\
\langle a| H|b\rangle=\frac{(-1)^{a b}}{\sqrt{2}} \tag{53}
\end{gather*}
$$

A general qubit rotation is defined by $e^{i \hat{\theta} \cdot \vec{\sigma}}$, where $\vec{\theta}$ is a 3 dimensional real vector. For any real number $\theta$,

$$
\begin{equation*}
e^{i \theta \sigma_{Z}}=\cos \theta+i \sigma_{Z} \sin \theta \tag{54}
\end{equation*}
$$

Eq.(54) can be proven by expressing both sides of it as a power series. Applying a rotation to Eq.(54), it becomes

$$
\begin{equation*}
e^{i \vec{\theta} \cdot \vec{\sigma}}=\cos \theta+i \vec{\sigma} \cdot \hat{\theta} \sin \theta, \tag{55}
\end{equation*}
$$

where $\vec{\theta}$ is a 3 dimensional real vector, $\theta$ is its magnitude, and $\hat{\theta}=\vec{\theta} / \theta$.

## 4 Hadamard Matrices

The 1 bit Hadamard matrix is defined by

$$
H_{1}=\frac{1}{\sqrt{2}} \begin{array}{l|rr} 
& 0 & 1  \tag{56}\\
\hline & 0 & 1 \\
1 & 1 & -1
\end{array} .
$$

The $N_{B}$-bit Hadamard matrix is defined as the $N_{B}$-fold tensor product of $H_{1}$ :

$$
\begin{equation*}
H_{N_{B}}=\underbrace{H_{1} \otimes H_{1} \otimes \ldots \otimes H_{1}}_{N_{B} \text { factors }} . \tag{57}
\end{equation*}
$$

For example, for $N_{B}=2$,
where we have labelled the rows and columns with binary numbers in increasing dictionary order. Equivalently, for bits $\vec{\alpha}=\left(\alpha_{1}, \alpha_{1}, \ldots, \alpha_{N_{B}}\right)$,

$$
\begin{equation*}
H_{N_{B}}(\vec{\alpha})=\prod_{i=1}^{N_{B}} H_{1}\left(\alpha_{i}\right) . \tag{59}
\end{equation*}
$$

We will often use a plain $H$ to represent $H_{1}$. Since $\left(H_{1}\right)_{b, b^{\prime}}=\frac{(-1)^{b b^{\prime}}}{\sqrt{2}}$ for $b, b^{\prime} \in$ Bool, it follows that

\left(H_{N_{B}}\right)_{\vec{b}, \overrightarrow{b^{\prime}}}=\frac{(-1)^{\vec{b} \cdot \overrightarrow{b^{\prime}}}}{\sqrt{2^{N_{B}}}} \tag{60}

for $\vec{b}, \overrightarrow{b^{\prime}} \in \operatorname{Bool}^{N_{B}}$. Since $H_{1}^{2}=1$ and $H_{1}^{T}=H_{1}$, where $T=$ transpose, it follows that

\end{equation*}
$$

and

\begin{equation*}
H_{N_{B}}^{T}=H_{N_{B}} . \tag{62}
\end{equation*}

## 5 CNOTs

We define a CNOT $\left(\mathrm{C}=\right.$ controlled, $\left.\mathrm{NOT}=\sigma_{X}\right)$ by:

$$
\begin{equation*}
\operatorname{CNOT}(\alpha \rightarrow \beta)=\operatorname{CNOT}(\beta \leftarrow \alpha)=\sigma_{X}(\beta)^{n(\alpha)}=(-1)^{n(\alpha) n_{X}(\beta)}=\underset{\sim}{\ldots} \tag{63}
\end{equation*}
$$

$\alpha$ is called the control qubit and $\beta$ is called the target qubit. The CNOT can be easily generalized to have more than one control qubit:

$$
\begin{equation*}
\sigma_{X}^{n(\alpha) n(\beta)}(\gamma)=(-1)^{n(\alpha) n(\beta) n_{X}(\gamma)}=\underset{\ddagger}{\ddagger} \tag{64}
\end{equation*}
$$

Other operators related to CNOT are

$$
\begin{equation*}
\sigma_{X}(\beta)^{\bar{n}(\alpha)}=(-1)^{\bar{n}(\alpha) n_{X}(\beta)}=\underset{\text { —— }}{ } \tag{65}
\end{equation*}
$$

and

$$
\begin{equation*}
\sigma_{Z}^{n(\alpha)}(\beta)=\sigma_{Z}^{n(\beta)}(\alpha)=(-1)^{n(\alpha) n(\beta)}= \tag{66}
\end{equation*}
$$

For any $a, b, c \in$ Bool,

$$
\begin{align*}
\sigma_{X}(\beta)^{n(\alpha)}|a, b\rangle_{\alpha \beta} & =|a, b \oplus a\rangle  \tag{67}\\
\sigma_{X}^{n(\alpha) n(\beta)}(\gamma)|a, b, c\rangle_{\alpha \beta \gamma} & =|a, b, c \oplus a b\rangle  \tag{68}\\
\sigma_{X}(\beta)^{\bar{n}(\alpha)}|a, b\rangle_{\alpha \beta} & =|a, b \oplus \bar{a}\rangle  \tag{69}\\
(-1)^{n(\alpha) n(\beta)}|a, b\rangle_{\alpha \beta} & =(-1)^{a b}|a, b\rangle \tag{70}
\end{align*}
$$

Some workers represent a CNOT by

notation reminds us of the $\oplus$ in Eq.(67), whereas the the $X$ in $\sigma_{X}(\beta)^{n(\alpha)}$.

\end{equation*}
$$

proof:

$$
\begin{align*}
\sigma_{X}(\alpha)^{n(\beta)} & =(-1)^{n_{X}(\alpha) n_{Z}(\beta)}  \tag{73}\\
& =1-2 n_{X}(\alpha) n_{Z}(\beta)  \tag{74}\\
& =1-2\left(\frac{1-\sigma_{X}(\alpha)}{2}\right)\left(\frac{1-\sigma_{Z}(\beta)}{2}\right)  \tag{75}\\
& =\frac{1}{2}\left[1+\sigma_{X}(\alpha)+\sigma_{Z}(\beta)-\sigma_{X Z}(\alpha, \beta)\right] \tag{76}
\end{align*}
$$

QED

Claim: (Permuting 2 CNOTs in a chain)


## proof:

Let LHS and RHS stand for the left and right hand sides of Eq.(77). For $a, b, c \in$ Bool,

\text { LHS }|a, b, c\rangle_{\alpha \beta \gamma} & =\sigma_{X}(\alpha)^{n(\beta)} \sigma_{X}(\beta)^{n(\gamma)}|a, b, c\rangle  \tag{79}\\
& =\sigma_{X}(\alpha)^{n(\beta)}|a, b \oplus c, c\rangle  \tag{80}\\
& =|a \oplus b \oplus c, b \oplus c, c\rangle \tag{81}
\end{align*}
$$

$$
\begin{align*}
R H S|a, b, c\rangle_{\alpha \beta \gamma} & =\sigma_{X}(\alpha)^{n(\gamma)} \sigma_{X}(\beta)^{n(\gamma)} \sigma_{X}(\alpha)^{n(\beta)}|a, b, c\rangle  \tag{82}\\
& =\sigma_{X}(\alpha)^{n(\gamma)} \sigma_{X}(\beta)^{n(\gamma)}|a \oplus b, b, c\rangle  \tag{83}\\
& =\sigma_{X}(\alpha)^{n(\gamma)}|a \oplus b, b \oplus c, c\rangle  \tag{84}\\
& =|a \oplus b \oplus c, b \oplus c, c\rangle \tag{85}
\end{align*}
$$

Finally, note that $\operatorname{CNOT}(\gamma \rightarrow \alpha)$ and $\operatorname{CNOT}(\gamma \rightarrow \beta) \operatorname{CNOT}(\beta \rightarrow \alpha)$ commute.

A mnemonic for remembering Eq.(77): On the left hand side of Eq. (77), we have a "chain" $\operatorname{CNOT}(\alpha \leftarrow \beta) \operatorname{CNOT}(\beta \leftarrow \gamma)$ of CNOTs. When $\operatorname{CNOT}(\alpha \leftarrow \beta)$ is moved to the right (or to the left), over $\operatorname{CNOT}(\beta \leftarrow \gamma)$, it leaves behind as a "wake" the CNOT within the dotted box. The wake $\operatorname{CNOT}(\alpha \leftarrow \gamma)$ points from the beginning to the end of the original chain $\operatorname{CNOT}(\alpha \leftarrow \beta) \operatorname{CNOT}(\beta \leftarrow \gamma)$.

Throughout QC Paulinesia, we will refer to equations, like Eq.(77), wherein two operators are permuted and a wake is produced, as "wake identities". Eq. (177) is the first of many wake identities we will present.

A mnemonic for remembering Eq. (861): On the left hand side of Eq. (861), we have a "loop chain" $\operatorname{CNOT}(\alpha \leftarrow \beta) \operatorname{CNOT}(\beta \leftarrow \alpha)$ of CNOTs. When $\operatorname{CNOT}(\alpha \leftarrow \beta)$ is moved over $\operatorname{CNOT}(\beta \leftarrow \alpha)$, it leaves behind as a "wake" the two CNOTs within the dotted box. The wake and the non-wake parts are identical.

& =\sigma_{Z}(\alpha) \sigma_{Z}(\beta)|a, b \oplus a\rangle  \tag{92}\\
& =(-1)^{b}|a, b \oplus a\rangle \tag{93}
\end{align*}
$$

QED
alternative proof:

$$
\begin{align*}
\sigma_{X}(\beta)^{n(\alpha)} \sigma_{Z}(\beta) \sigma_{X}(\beta)^{n(\alpha)} & =\left[\sigma_{X}(\beta) n(\alpha)+\bar{n}(\alpha)\right] \sigma_{Z}(\beta)\left[\sigma_{X}(\beta) n(\alpha)+\bar{n}(\alpha)\right]  \tag{94}\\
& =\sigma_{Z}(\beta)\left[-\sigma_{X}(\beta) n(\alpha)+\bar{n}(\alpha)\right]\left[\sigma_{X}(\beta) n(\alpha)+\bar{n}(\alpha)\right]  \tag{95}\\
& =\sigma_{Z}(\beta)[-n(\alpha)+\bar{n}(\alpha)]  \tag{96}\\
& =\sigma_{Z}(\beta) \sigma_{Z}(\alpha) . \tag{97}
\end{align*}

Eqs. (100) and (101) suggest a way of converting a non-nearest neighbor CNOT into a sequence of nearest neighbor ones.

## 6 CNOT Generalizations

In this section, $\vec{\alpha}, \vec{\beta}$ and $\vec{\gamma}$ will denote disjoint sets of distinct qubits. That is, any two different components of the same vector, or two components of different vectors represent different qubits.

Suppose $U$ is a unitary matrix. Furthermore, for $j=1,2$, suppose $\pi_{j}$ is a projection operator (i.e., $\pi_{j}^{2}=\pi_{j}$, the eigenvalues of $\pi_{j}$ are all 0 or 1 ). Some examples of projection operators $\pi_{j}$ that are of interest to us: $1, n(\alpha), n(\alpha) n(\beta), n(\alpha) \bar{n}(\beta)$, $n(\alpha) n(\beta) n(\gamma)$, etc. It is convenient to generalize CNOT diagrammatic notation as follows. Let

$$
\begin{equation*}
\underset{\pi_{\pi_{2}}^{\pi_{1}}-\vec{\alpha}-\vec{\beta}}{ }=(-1)^{\pi_{1}(\vec{\alpha}) \pi_{2}(\vec{\beta})}, \tag{102}
\end{equation*}
$$

and

$$
\begin{equation*}
\frac{\pi_{1}-\vec{\alpha}}{I-\vec{\beta}}=U(\vec{\beta})^{\pi_{1}(\vec{\alpha})} . \tag{103}
\end{equation*}
$$

We will refer to an operator of the form Eq.(103) as a projector controlled unitary operator, or simply as a controlled $\mathbf{U}$, in analogy to a controlled NOT, for which $U=\sigma_{X}=$ the NOT operator. The set of operators of the form Eq.(102) is a subset of the set of operators of the form Eq.(103). Indeed, given any projection operator $\pi_{2}(\vec{\beta})$, one can always define the unitary operator $U(\vec{\beta})=(-1)^{\pi_{2}(\vec{\beta})}=1-2 \pi_{2}(\vec{\beta})$. Hence,


Special cases of Eqs.(102) and (103) are:

$$
\begin{align*}
& (-1)^{n(\alpha) n(\beta)}=\square-\sqrt[\square]{\square}=\frac{\sqrt[n]{n}-\sqrt[n]{\sigma_{Z}}-}{\square-} \tag{105}
\end{align*}
$$

and, for any $2 \times 2$ unitary matrix $U$ :


We will refer to the operator of Eq.(107) as an $n^{1}$ controlled $\mathbf{U}$, and to the operator of Eq. (108) as an $n^{2}$ controlled U.

Suppose $U$ is any $2 \times 2$ unitary matrix. It can always be diagonalized as follows:

U=V \operatorname{diag}\left(e^{i \theta_{1}}, e^{i \theta_{2}}\right) V^{\dagger} \tag{109}
\end{equation*}
$$

where $\theta_{1}, \theta_{2}$ are reals numbers and $V$ is a unitary matrix. If we set

\end{equation*}

and

\begin{equation*}
\bar{\theta}=\frac{\theta_{1}+\theta_{2}}{2}, \tag{111}

then

\begin{equation*}
U=e^{i \bar{\theta}} V e^{i \Delta \sigma_{Z}} V^{\dagger} \tag{112}
\end{equation*}
$$

## Claim:

For any $2 \times 2$ unitary matrix $U(\beta)$ given by Eq.(112), and projection operator $\pi_{1}(\vec{\alpha})$,

Check that both sides agree when $\pi_{1}$ equals 0 and 1 .
QED
alternative proof:

$$
\begin{equation*}
U(\beta)^{n(\alpha)}=e^{i \bar{\theta} n(\alpha)} V(\beta) e^{i \Delta \sigma_{Z}(\beta) n(\alpha)} V(\beta)^{\dagger} \tag{114}
\end{equation*}
$$

$$
\begin{align*}
e^{i \Delta \sigma_{Z}(\beta) n(\alpha)} & =e^{i \Delta \sigma_{Z}(\beta) \frac{1}{2}\left[1-\sigma_{Z}(\alpha)\right]}  \tag{115}\\
& =e^{i \frac{\Delta}{2} \sigma_{Z}(\beta)} e^{-i \frac{\Delta}{2} \sigma_{Z}(\beta) \sigma_{Z}(\alpha)}  \tag{116}\\
& =e^{i \frac{\Delta}{2} \sigma_{Z}(\beta)} \sigma_{X}(\beta)^{n(\alpha)} e^{-i \frac{\Delta}{2} \sigma_{Z}(\beta)} \sigma_{X}(\beta)^{n(\alpha)} \tag{117}
\end{align*}

This proof still holds if we replace $n(\alpha)$ by $\pi_{1}(\vec{\alpha})$ and $\sigma_{Z}(\alpha)$ by $(-1)^{\pi_{1}(\vec{\alpha})}$. QED

Eqs. (118) and (119) suggest a way of converting any $n^{r}$ controlled $U$, for an integer $r \geq 1$, into a sequence of gates containing no controlled $U^{\prime}$ 's but containing $n^{s}$ controlled NOTs, where $s \leq r$.

1 & 1 \\

\pi_{2}-\pi_{1}-\vec{\alpha} \\
U_{2} U_{1}^{\dagger} U_{2}^{\dagger} \\
U_{2}-\sqrt[U_{1}]{ }-\vec{\beta}
\end{gathered} .
$$

(Dotted box encloses wake.) Algebraically,

U_{1}(\vec{\beta})^{\pi_{1}(\vec{\alpha})} U_{2}(\vec{\beta})^{\pi_{2}(\vec{\alpha})}=\left(U_{1} U_{2} U_{1}^{\dagger} U_{2}^{\dagger}\right)^{\pi_{1} \pi_{2}} U_{2}^{\pi_{2}} U_{1}^{\pi_{1}} \tag{121}
\end{equation*}

Check that both sides of Eq. (120) agree when $\left(\pi_{1}, \pi_{2}\right)$ equals each element of Bool $^{2}$. QED

One qubit operations (such as internal or final one qubit measurements or one qubit rotations) are "cheap" compared with two qubit operations such as CNOTs and two qubit measurements (either internal or final). This is because two qubit operations are slower and they require two qubits to interact, which opens the door for noise from the environment to creep in. So in this section we will pay attention only to the number of two qubit operations. Let bibit stand for two bits. Next we will show what I like to call the "one to two" conversion rules. Namely, given a single CNOT, one can always convert it to two bibit operations. Likewise, given a single bibit operation, one can always convert it to two CNOTs.

L H S & =\left\langle\left. B^{00}\right|_{\alpha \beta} \sigma_{Z}^{z}(\beta) \sigma_{X}^{x}(\beta) \sigma_{X}^{x}(\beta) \sigma_{Z}^{z}(\beta) \mid \psi\right\rangle_{\alpha}\left|B^{00}\right\rangle_{\beta \gamma}  \tag{254}\\
& =\left\langle\left. B^{00}\right|_{\alpha \beta} \mid \psi\right\rangle_{\alpha}\left|B^{00}\right\rangle_{\beta \gamma}, \tag{255}
\end{align*}
$$

so we only need to prove Eq. (253) for $x=z=0$.
For an arbitrary $a \in$ Bool,

$$
\begin{align*}
\left\langle\left. B^{00}\right|_{\alpha \beta} \mid a\right\rangle_{\alpha}\left|B^{00}\right\rangle_{\beta \gamma} & =\left(\frac{1}{2}\right)\left(\left\langle\left. 00\right|_{\alpha \beta}+\left\langle\left. 11\right|_{\alpha \beta}\right) \mid a\right\rangle_{\alpha}\left(|00\rangle_{\beta \gamma}+|11\rangle_{\beta \gamma}\right)\right.  \tag{256}\\
& =\frac{\left\langle\left. a\right|_{\beta}\right.}{2}\left(|00\rangle_{\beta \gamma}+|11\rangle_{\beta \gamma}\right)  \tag{257}\\
& =\frac{|a\rangle_{\gamma}}{2} \tag{258}
\end{align*}
$$

Alternatively, note that

For any $x, z \in$ Bool,

proof:
Follows immediately from Eq.(253).

## 13 Dense Coding

Claim:
For any $a, b \in$ Bool,

(264)
proof:
Let LHS and RHS denote the left and right hand sides of Eq.(264).

$=\sigma_{X}{ }^{n(\alpha)}(\gamma) \sigma_{Z}{ }^{n(\beta)}(\gamma)|a, b\rangle_{\alpha \beta}\left|B^{00}\right\rangle_{\gamma \delta}$


## 14 Quantum Fourier Transform

For this section, it is especially important that the reader read the Notation section of QC Paulinesia. The Notation section explains what we mean by natural labelling. Natural labelling will be used in this section.

Given a vector $\vec{x}=\left(x_{N_{B}-1}, \ldots, x_{1}, x_{0}\right) \in$ Bool $^{N_{B}}$, let $R \vec{x}=\left(x_{0}, x_{1}, \ldots, x_{N_{B}-1}\right)$. Thus $R$ is the matrix that reverses the components of an $N_{B}$ dimensional vector. For example, for $N_{B}=4$,

$$
R=\left(\begin{array}{llll}
0 & & & 1  \tag{270}\\
& & 1 & \\
& 1 & & \\
1 & & & 0
\end{array}\right)
$$

We will also use $R$ to denote a map from the Hilbert space of $N_{B}$ qubits to itself such that $R|\vec{x}\rangle=|R \vec{x}\rangle$ for $\vec{x} \in \operatorname{Bool}^{N_{B}}$. We will also use $R$ to denote the map $R: Z_{0, N_{B}-1} \rightarrow Z_{0, N_{B}-1}$ such that $R(i)=N_{B}-1-i$. For example, for $N_{B}=4, R$ maps $0 \rightarrow 3,1 \rightarrow 2,2 \rightarrow 1,3 \rightarrow 0$.

For any $\alpha, \beta \in Z_{0, N_{B}-1}$, define

$$
\begin{equation*}
\square=V(\alpha, \beta)=\exp \left[i \pi \frac{n(\alpha) n(\beta)}{2^{|\alpha-\beta|}}\right]=(-1)^{\frac{n(\alpha) n(\beta)}{2^{|\alpha-\beta|}}} . \tag{271}
\end{equation*}
$$

Note that normally in QC Paulinesia, we use $-=\sigma_{Z}^{n(\alpha)}(\beta)=(-1)^{n(\alpha) n(\beta)}$, so the definition given by Eq.(271) applies only to this section.

For any $x \in Z_{0, N_{S}-1}$, the Quantum Fourier Transform of $|x\rangle$ is defined by

$$
\begin{equation*}
U_{F T}|x\rangle=\frac{1}{\sqrt{N_{S}}} \sum_{y=0}^{N_{S}-1} e^{i \frac{2 \pi x y}{N_{S}}}|y\rangle . \tag{272}
\end{equation*}
$$

Henceforth, for simplicity, we will often assume $N_{B}=4$. It will be obvious how to extend our arguments to other values of $N_{B}$.

## Claim:

For any $\vec{x}=\left(x_{3}, x_{2}, x_{1}, x_{0}\right) \in$ Bool $^{4}$,

proof:
Recall from the Notation section that $\vec{\nu}=\left(N_{B}-1, \ldots, 2,1,0\right)$. Let $n=2^{\vec{\nu}} \cdot \vec{n}$ and $x=2^{\vec{\nu}} \cdot \vec{x}$. Then

$$
\begin{align*}
U_{F T}|\vec{x}\rangle_{\vec{\nu}} & =\frac{1}{\sqrt{N_{S}}} e^{\frac{i 2 \pi x n}{N_{S}}} \sum_{\vec{y} \in \text { Bool }^{N_{B}}}|\vec{y}\rangle_{\vec{\nu}}  \tag{274}\\
& =e^{i \frac{2 \pi x n}{N_{S}}} H(\vec{\nu})|0\rangle_{\vec{\nu}} . \tag{275}
\end{align*}
$$

Furthermore,

$$
\begin{align*}
\exp \left[\frac{i 2 \pi x n}{16}\right]= & e^{\left[\frac{i 2 \pi}{16}\left(8 x_{3}+4 x_{2}+2 x_{1}+x_{0}\right)(8 n(3)+4 n(2)+2 n(1)+n(0))\right]}  \tag{276}\\
& =\exp \left[i 2 \pi\left\{\begin{array}{l}
n(3)\left(\frac{x_{0}}{2}\right) \\
+n(2)\left(\frac{x_{1}}{2}+\frac{x_{0}}{4}\right) \\
+n(1)\left(\frac{x_{2}}{4}+\frac{x_{1}}{4}+\frac{x_{0}}{8}\right) \\
+n(0)\left(\frac{x_{3}}{2}+\frac{x_{2}}{4}+\frac{x_{1}}{8}+\frac{x_{0}}{16}\right)
\end{array}\right\}\right], \tag{277}
\end{align*}
$$

where, in Eq.(277), we omitted all terms in the argument of the exponential that yielded contributions of the form $e^{i 2 \pi(\text { integer })}$.

Note that for any $x \in$ Bool and bit $\alpha$,

$$
\begin{equation*}
(-1)^{x n(\alpha)} H(\alpha)|0\rangle_{\alpha}=\sigma_{Z}^{x}(\alpha) H(\alpha)|0\rangle_{\alpha}=H(\alpha)|x\rangle_{\alpha} . \tag{278}
\end{equation*}
$$

Thus,

$$
\begin{align*}
& \exp \left[\frac{i 2 \pi x n}{16}\right] H(\vec{\nu})|0\rangle_{\vec{\nu}}=\left\{\begin{array}{l}
\exp \left[i \pi n(3) x_{0}\right] H(3)|0\rangle_{3} \\
\exp \left[i \pi n(2)\left(x_{1}+\frac{x_{0}}{2}\right)\right] H(2)|0\rangle_{2} \\
\exp \left[i \pi n(1)\left(x_{2}+\frac{x_{1}}{2}+\frac{x_{0}}{4}\right)\right] H(1)|0\rangle_{1} \\
\exp \left[i \pi n(0)\left(x_{3}+\frac{x_{2}}{2}+\frac{x_{1}}{4}+\frac{x_{0}}{8}\right)\right] H(0)|0\rangle_{0}
\end{array}\right.  \tag{279}\\
& =\left\{\begin{array}{l}
H(3)\left|x_{0}\right\rangle_{3} \\
\exp \left[i \pi n(2)\left(\frac{x_{0}}{2}\right)\right] H(2)\left|x_{1}\right\rangle_{2} \\
\exp \left[i \pi n(1)\left(\frac{x_{1}}{2}+\frac{x_{0}}{4}\right)\right] H(1)\left|x_{2}\right\rangle_{1} \\
\exp \left[i \pi n(0)\left(\frac{x_{2}}{2}+\frac{x_{1}}{4}+\frac{x_{0}}{8}\right)\right] H(0)\left|x_{3}\right\rangle_{0}
\end{array}\right.  \tag{280}\\
& =\left\{\begin{array}{l}
H(3) \\
=\left\{\begin{array}{l}
\exp \left[i \pi n(2)\left(\frac{n(3)}{2}\right)\right] H(2) \\
\exp \left[i \pi n(1)\left(\frac{n(2)}{2}+\frac{n(3)}{4}\right)\right] H(1) \\
\exp \left[i \pi n(0)\left(\frac{n(1)}{2}+\frac{n(2)}{4}+\frac{n(3)}{8}\right)\right] H(0)
\end{array}\right\} R|\vec{x}\rangle
\end{array}\right\} \begin{array}{l}
H(3) V(3,2) H(2) V(3,1) V(2,1) H(1) V(3,0) V(2,0) V(1,0) H(0) R|\vec{x}\rangle
\end{array} \tag{281}
\end{align*}
$$

QED

Claim: (3-2-1 form equals 1-2-3 form)

proof:
Obvious.
QED
We call "the 1-2-3 form" the form of $U_{F T}$ given by Eq.(283). We call "the 3-2-1 form" the form given by Eq.(284). The numbers 1,2,3 refer to the number of $V$ operators between the $H$ operators.

## Claim:

$U_{F T}$ is a symmetric matrix.
proof:
Let $\dagger=$ Hermitian conjugate, $*=$ complex conjugate, so $\dagger *=$ transpose. For any $x, y \in Z_{0, N_{S}-1}$,

$$
\begin{equation*}
\langle y| U_{F T}|x\rangle=\exp \left(\frac{i 2 \pi x y}{N_{S}}\right)=\langle y| U_{F T}^{\dagger *}|x\rangle \tag{285}
\end{equation*}
$$

QED
alternative proof:


QED
For distinct bits $\alpha, \beta$, let $V(\alpha, \beta)_{n(\beta) \rightarrow b}$ denote the result of substituting $n(\beta)$ in $V(\alpha, \beta)$ by $b \in$ Bool.

Claim:
For any $\vec{x}=\left(x_{3}, x_{2}, x_{1}, x_{0}\right) \in$ Bool $^{4}$ and $\vec{y}=\left(y_{3}, y_{2}, y_{1}, y_{0}\right) \in$ Bool $^{4}$,

proof:

Obvious.
QED

## Claim:

proof:
Check that the right hand side of Eq. (290) maps $0 \rightarrow 3,1 \rightarrow 2,2 \rightarrow 1$, and $3 \rightarrow 0$. QED
